One of RigDig's information sources is the Federal Motor Carrier Safety Administration (FMCSA). RigDig reports the information as it is reported to RigDig by FMCSA. If you find any discrepancies in the information, please use the following methods to update the FMCSA source.



#### Motor Carrier Information

All motor carriers operating commercial motor vehicles in interstate commerce are required to file an updated form MCS-150 (Motor Carrier Identification report) every 2 years. Click [here](#) to update your MCS-150.



#### Accident & Inspection Records

The DataQs system is an electronic means for filing concerns about Federal and State data released to the public by the Federal Motor Carrier Safety Administration (FMCSA). Through this system, data concerns are automatically forwarded to the appropriate office for resolution. The system also allows filers to monitor the status of each filing.
